The annual membership dues are payable in U.S. dollars and are based on the amount of assets reported by the affiliated credit unions/financial cooperatives. The board of directors reviews and votes upon new membership applications.

- 1. A letter of intent from your board of directors requesting World Council membership and certifying that:
  - a. The application was approved by a majority of your directors
  - b. Your organization will abide by the **World Council Bylaws** and the **WOCCU International Operating Principles**
  - c. Your organization will pay its dues in full
- 2. The bylaws of your organization
- 3. The financial statements of your organization for the last three years including balance sheets and income statements audited by an accredited accounting firm

The application is complete when your organization pays the annual dues in full.
